Fig. 3 Extended immunophenotype of proliferative and resting CLL fractions. Surface markers were analyzed by flow cytometry in CXCR4^{dim}CD5^{bright} (black) and CXCR4^{bright}CD5^{dim} (white) fractions. All surface molecules depicted, but CCR7 and CTLA4, were greater in CXCR4^{dim}CD5^{bright} fractions, in terms of percent positive cells (**A**) or mean fluorescence intensity (**B**) or of both. CCR7 and CTLA4 were higher in CXCR4^{bright}CD5^{dim} fraction. * P < 0.01 and § P < 0.05 (Paired Student t test)
